WATCH THE ICE & RED FLAGS ARE POSTED

As temperatures continue to drop, we want to send a friendly but important reminder about winter safety. Even when the surface of a lake appears frozen, ice thickness can vary greatly, and it may not be strong enough to support weight. This can create extremely dangerous situations.

If the ice does crack, drop to your hands and knees and crawl off the ice. This helps distribute your weight more widely, while reducing your chances of falling through the ice.

Educating yourself on ice safety and what to do in ice emergencies is a critical step in staying safe on the ice. If you are unsure of conditions, it is best to refrain from any ice activities - if in doubt, don't go out! (<https://preventionworks-nj.org/news-and-events/safety-frozen-lake-or-pond>)

BOROUGH ORDINANCE 185-11

Chapter 185. Recreation Areas
 Article II. Use of Recreational Property
 § 185-11. Use of waterways.

- It shall be unlawful for any person to create any obstruction to navigation in any waterway.
- It shall be unlawful for any person to extend a dock or pier more than 12 feet into any waterway, measured from the property line along any such waterway, and more than 20 feet in width.
- It shall be unlawful to throw, place, or dispose of, in any way, any litter into any waterway.
- It shall be unlawful for any person to diminish the surface quality of any ice-covered waterway, or to create hazards for skaters on any ice-covered waterway, by making or causing holes in the ice (except for ice fishing in designated areas as may be designated by the Medford Lakes Colony Club); by starting or maintaining fires on any ice-covered waterway; or by throwing or placing litter on any ice-covered waterway.
- It shall be unlawful for any person to construct any bulkhead, or in any other manner rebuild any shoreline, in such a manner that it extends the shoreline more than one foot from that in existence at the time of passage of this article, or in such a manner that it creates an impediment to the natural action of wind and water which did not previously exist, or in such a manner that it substantially enlarges the land area of the property.

NEW E-BIKE LAWS

Medford Lakes Police Department has asked us to share the following information: Questions should be directed to the MLPD at 609-654-2156.

Effective January 19, 2026, there are new laws pertaining to riding E-bikes (electric bicycles). If you or your child has an E-bike, please read and understand these new laws.

Under the new laws:

- E-bikes are no longer classified under the three-tier system (Class 1, 2, 3). All E-bikes now fall under one category.
- All E-bike riders must have a valid driver's license (17+) or a motorized bicycle license (ages 15-16).
- Children (age 14) and younger are prohibited from operating E-bikes.
- All E-bikes must be registered with the NJ MVC.
- All E-bikes must have liability insurance.
- A six-month grace period has been established to provide riders with sufficient time to comply with these regulations.


